SETTLEMENT AGREEMENT

Plaintiff Jaclyn Hall, on behalf of herself and her minor child, Z.H.2, and Defendants Alabama High School Athletic Association and Heath Harmon hereby agree to the following terms to settle the claims in the above-captioned case:


1. Defendants will not limit or impede Jaclyn Hall’s son Z.H.2 in his participation in athletic activities as a result of his status as a CHOOSE Act participating student or his participation in this lawsuit. However, all other eligibility rules still apply to Z.H.2.
2. Defendants will not take any adverse action against Jaclyn Hall’s son Z.H.2. for his participation in athletic activities based on orders entered in the above-captioned case.

3. Defendants will not retaliate against Jaclyn Hall’s son Z.H.2 for their advocacy in support of his participation in athletic activities.
4. Plaintiff will dismiss the above-captioned case against defendants without taxation of fees and costs.
5. All parties consent to the continued jurisdiction of the court in the above-captioned case for the limited purpose of enforcing this agreement.
